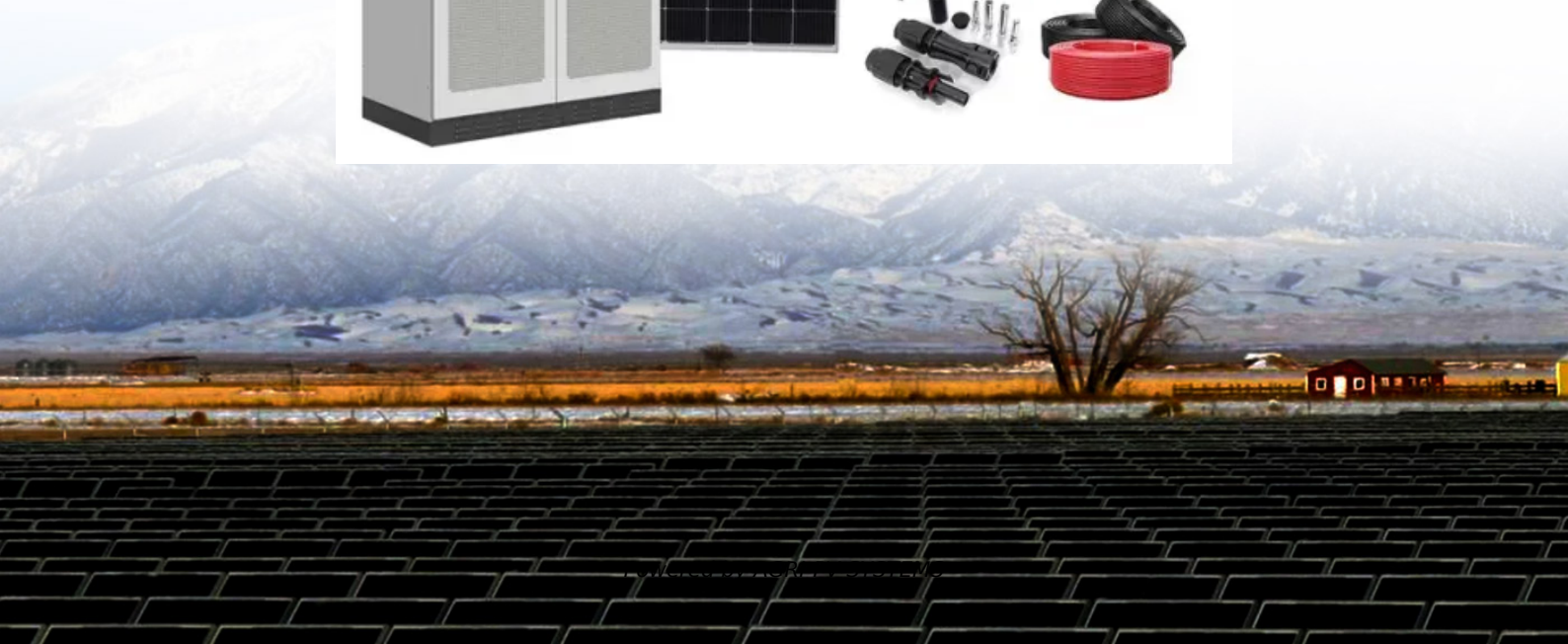

Construction Requirements by Service

Construct and place into operation within 12 months of initial license grant date, or if modified under the Second Report and Order (FCC 96-27) on or before August
