Overview

Through its Report and Order and Declaratory Ruling, the FCC helps to advance deployment of broadband infrastructure and make the pole attachment process faster, more transparent, and more cost-effective by: (1) clarifying that utilities may not charge communications attachers.

Enforcement Overview

If an act (or failure to act) that constitutes a violation occurs more than once or for more than one day, the FCC may treat these violations as separate offenses.

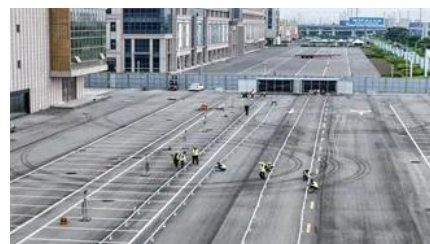
