

Tax rate for imported solar container battery cabinets in Iran

According to Iran's current customs laws, the import duty for solar panels is usually 5% of the CIF value (which includes the cost of goods, international transportation, and insurance). Additionally, importers are required to pay 9% value-added tax (VAT).

Iran import duty rates are revised and approved by the Cabinet every year and may also increase or decrease during the year, which will present as internal Iranian customs administration's circulars.

According to Iranian customs regulations, solar panel imports are subject to a 5% import duty based on the CIF value (Cost, Insurance, and Freight) and a 9% Value Added Tax (VAT).

Customs Regulations in Iran

Value Added Tax (VAT): Imported goods are generally subject to a VAT rate of 9 percent in Iran. This tax is calculated based on the customs value of the goods plus any applicable customs duties.
